

3) TRUST PROPERTY :-

The Trust property shall consist of the initial nucleus amount of Rs. 5,00/- contributed and settled by Mr. Hemant Chanchal Mal Lodha, shall be the corpus of Trust and this amount can not be incurred or expended. The interest therefrom and all contribution, funds donations of amount received therefrom or derived with the aid of any such amount or property and all other amounts, rents and movable or immovable properties and interest by whatever name called which the Trust may receive or acquire or come in possession of the trust from time to time shall be the property or the Trust. The properties of the Trust as acquired or received shall vest in the trustees in office who shall utilize the same for the objects of the Trust.

4) OBJECTS OF TRUST :-

1. To launch and maintain web site to fulfill the objectives of trust.
2. To bridge the gap and work as help link between under privileged and patron.
3. To publish books and literature useful for masses and sale in the society and utilise receipt for fulfilment of objective of trust.
4. To carry out research in the branch of physiotherapy and to run research institutes for exploiting opportunities and providing facilities for the purpose of research in the various branches or medical science and other allied scientific branches.
5. To organize various competitions on environment protection, road, safety, home safety etc. for school & college students for spreading awareness in various fields.


- 6. To provide carrer guidance to unemployed youth (students) belonging to various sections of society. To organize career guidance programmes in the nature of training course, information center lectures, workshops so as to inspire them for self employment. To establish and run Vocational, Professional, Technical, industrial Training Institutes such as Tailoring, Embroidary, Business Management, Banking Accounts, Computer, Book Binding, Craft, Electronics, electrical, skin-beauty culture and various courses recognised by Vocational & Technical Board of State & Central Govt. and any other trainings essential for the welfare of the youth.
- 7. To run institutions in the nature of arts schools colleges for teaching music, singing, dance, painting, arts, craft work and other cultural activities etc. To organise and celebrate national, social, cultural programmes like debate competitions, sports tournaments, seminars, symposiums, lectures series etc. for the psycho-physiological development of the youth.
- 8. To establish and run Shishugruha, Balasadan, Child Care Centre, Creche Units, Certified School, Orphanage Home, Short stay home, Day-care Centres & Ashram School for S.C. S.T., N.T., & Backward classes students and generally for poor and needy sections of society.
- 9. To establish and run Girls Hostels, short - stay homes, and Working Womens Hostels. To establish and run libraries in different areas.
- 10. To establish and run educational, training institutes, schools/hostels and rehabilitation centres for physically handicapped, mentally retarded, Deaf, Dumb & Blinds.
- 11. To establish and run oldage home and short stay home, meditation, Yoga Centres.
- 12. To do all efforts for the educational, social, cultural, economical and overall development of women of various fields, prefarably, deserted, divorcee, widows, needy and poor womens coming under below poverty line of slum, rural and tribal areas to educate and motivate them for freedom and self dependency with human dignity.

To undertake the schemes introduced by State & Central Government for the Socioeconomic development of the people from slum, rural and tribal area, hereby to achieve the goal of development and betterment of women, child, physically handicapped etc. this purpose to undertake the schemes particularly introduced by the Social Welfare Department, Women & Child Development Department of State and central Government.
- 14. To run charitable hospitals, dispensaries, mobile health care units, dispensaries and nursing homes preferably for economically weaker sections in slum, rural, and tribal areas.
- 15. To organize blood donation camps, health diagnosis camps, eye treatment camps, HIV-AIDS awareness camps, relief camps for drug abused people.
- 16. To establish and run blood banks, eye-bank, Treatment-management, guidance centers for Haeomophilic, Thalasmic, Bone - marrow failure, Sickle - cells disease, HIV - AIDS rehabilitation and drug deaddiction centers. To establish and run a physiotherapy rehabilitation center so as to spread awareness among people regarding treatment and relief through physiotherapy.

6) **TENURE AND MODE OF SUCCESSION :-**

There shall be Board of Trustees consisting of 10 Trustees. Their designation shall be as under.

- 1) President - One, 2) Secretary - One, 3) Treasurer - One, 4) Member - Seven

If any vacancy arises due to death, resignation or any other reason, same shall be filled in by 2/3 Majority by the remaining trustees of the board of trustees for such office and for such period as may be decided.

However, if required and felt necessary at any time, the designation of office bearers i.e. President, Vice-President, Secretary, Jt. Secretary, Treasurer, may be changed by 2/3 majority of the trustees.

7. **QUALIFICATION FOR THE TRUSTEESHIP :-**

1. He should be an Indian having 18 years of age. He should not have been disqualified to be a trustee by any Authority or court.
2. He should not have encroached upon the property of trust.
3. He should not be a tenant of trust.
4. He should not belong to antisocial elements and should not be a gambler.
5. He should not have been punished by any court of Law for offence involving Moral Turpitude or for criminal offence.

8. **POWERS AND DUTIES OF OFFICE BEAREARS :-**

- a) **President :** To issue appropriate order for the day to day works of the trust. To control the proceedings of the trust and to give casting vote in the event of equal votes. To keep watch on the overall working of trust. To represent the trust in other offices and court. To call meetings of the trust. To call meetings of the trust, to approve bills of day to day expenses of trust. To execute the approved proposal. To exercise control over employees of trust. To accept monetary and other contributions on behalf of trust.

- c) **Secretary** : To conduct the proceedings of the meeting. To make correspondence, entertain the complaints. To maintain proceedings of the trust. To carry on all such duties and exercise all such power in the name of the Board of Trustees as may be decided by the Board of Trustees for the carrying out the objects of the trust and functioning thereof.
- e) **Treasurer** : To keep appropriate accounts, to prepare final accounts. To collect donations, funds subscription, and put all the accounts in boards of trustees and general body meeting.
- f) **Member** : To attend the Trust Meeting to vote in the meeting of the Trust.

9. **MEETINGS OF BOARD OF TRUSTEES :**

At least 4 meetings of the board of trustees will be held within a year. The notice of the meeting will be served 7 days in advance. Notice must reflect the date, time, place and agenda of the meeting called for Quorum required is 2/3 of the total members of the board of trustees. No quorum is required for adjourned meeting. Adjourned meeting shall be held on the same day at the same place after have an hour. But notice must reflect such information.

10. **EXTRA ORDINARY MEETING OF BOARD OF TRUSTEES :-**

An Extra ordinary meeting of Board of trustees can be called as an when required. Such meeting shall discuss only the agenda for which the meeting has been called for At least 24 hours earlier notice shall be necessary. Quorum shall be 2/3 of the total members of the Board of trustees. An adjourned meeting shall not require quorum. Adjourned meeting due to lack of quorum shall be held at the same place after half an hour at the same day but notice must reflect such information.

11. **NOTICE OF MEETING OF BOARD OF TRUSTEES :-**

The meetings of the board of trustees shall be called by the President for which a Notice, Mentioning the date, time agenda and venue of the Meeting shall be circulated to all the Trustees 7 days before the date of meeting. Notice to local members shall be served by dak book and in case of refusal to sign, by R.P.A.D. out of station Trustees shall be intimated by R.P.A.D. if it is not possible to serve them through dak-book.

12. **REQUISITION MEETING :-**

In case the regular meetings are not being held or for any other reason as the case may be, if at any time it is felt necessary to hold a meeting or Board of Trustees, At least 2/3 trustees can give in writing to the President of the trust for holding such requisition meeting Mentioning therein the reasons and agenda for calling such requisition meeting. If the such meeting is not called within Seven days from the receipt of such notice by the President then the requisitionists can call the such meeting by issuing notice under their signatures, 4 days notice shall be required for such meeting and the discussion shall be held only on the agenda mentioned in such notice for requisition meeting. The decision taken in such meeting shall be binding upon the Board of Trustees provided that notice should have been served upon all the trustees in writing.



13. **REMOVAL FROM TRUSTEESHIP :-**

Any trustees can be removed/dismissed from trusteeship on the following grounds in the meeting of Board of Trustees by 2/3 Majority. But before his removal/dismissal Opportunity of hearing and defending should be given to such member.

- 1) In case of a trustees if he remains absent in three consecutive meeting of the board of trustees.
- 2) If he resigns from trusteeship of the trust on his own.
- 3) If he acts against the interest of the trust.
- 4) If he behaves in an indescent manner with the other co-trustees in the meetings of Board of Trustees/General body.

- 5) If he is punished by any court of Law on account of Moral turpitude or criminal offence.
- 6) If he denies to follow the Rules and Regulations of the trust as contained in this Deed of Declaration.

14. **POWERS AND DUTIES OF BOARD OF TRUSTEES :-**

- A) The Board of Trustees shall have power of supervision and to execute all the affairs in accordance with the aims and objects of the trust.
- B) To carry out the proposal/Plans passed by board of trustees.
- C) To administer all affairs and property of the Trust.
- D) To appoint the employees for Trust, terminate them and to keep control over them for smooth functioning of the work of trust.
- E) To approve the last year's Receipts & Payments statement, Audited Accounts. Balance sheet etc. of the Trust as well as to approve the budget for the next financial year.
- F) All the Trustees of the Trust shall perform their duties consiously, having full responsibilities and in co-ordination with each other. And no power shall be misused/abused by any Board of Trustees.
- G) The Board of trustees may acquire for and on behalf of the trust any property movable or immovable out of the trust fund or the accretions thereto or from any source whatsoever and allow its property so acquired to be utilized by any individual person or a society or association or trust as may be deemed fit by the Board of trustees in accordance with law. However the trustees will be entitled to fix any fees or charges towards costs, expenses etc., incidental to such use subject to the provision of Bombay Public Trust Act, 1950.
- H) The trustee may associate for the purpose of achievement of its objects with any sociaty or institute in India or in any other foreign country to enable the trust to give the benefit of or to take the benefit or their reseaches and advance knowledge, both to the trust as well as to the community at large.

L) The trustees will be entitle, to hire, pruchase or sale or exchange any property movable or immovable if so required for carrying on the activies of the trust connected with the objects ofthe trust, and also to raise loans for such purpose and objects by hypothecation or mortgaging the property subject to the provisions of Bombay Public Trust Act, 1950. The trustees may donate or contribute to any association or individuals or society or trust carrying on the similar objects.

15) **FUND OF THE TRUST AND SOURCES OF INCOME :-**

*The sources ofthe Income/fund are as under :-*

- 1) Contributions Grants, Donations received from Trustees as well as from public.  
2) Other sources as permitted under the Bombay Public Trusts Act, 1950 etc. The Income of the trust shall be utilised for objects of the trust.

16) **PROVISIONS FOR TAKING LOAN/DEPOSITS :-**

The trust may take Loans/Deposits from any Member of Public or Bank in emergency and in the interest or trust only subject to having full security to repay and subject to prior permission from the Charity Commissioner, Nagpur provided that a resolution to that effect is passed in the meeting of Board of Trustees.

17) **PROCEDURE OF SALE & PURCHASE OF MOVABLE/IMMOVABLE PROPERTY :-**

The sale and purchase of movable and immovable Property can be made only in the interest/benefits of the trust and that too for fulfillment the objects of trust by passing the resolution in the meeting of Board of Trustees. Before selling any trust property prior permission of Charity Commissioner, Nagpur will be obtained.

18) **CASH IN HANDS :-**

The President of the trust (Board of Trustee) may keep such fund in his custody in form of cash in hand for day to day expenses ofthe trust or for any activity carried out by the trust as may be approved and found necessary by the Board of Trustees.

19. **BANK ACCOUNT :-**

All the fund/income of Trust shall be deposited in the Nationalised or co-operative bank or any post office. Bank transactions shall be operated under the Joint signatures of President, Secretary and Treasurer of the trust. Any two of the above can operate the Bank Account. But, President Signature will be must.

20. **PROCEDURE OF ALTERATION AND MODIFICATION OF TRUST DEED :-**

The provisions mentioned in this trust deed may be altered, modified or added by the resolution passed in the Meeting of Board of Trustees by not less than 2/3 majority of the Members present and confirmed by 2/3 majority of members of the Board of trustees in subsequent meeting held after 30 days. But the same will come into effect only after approval by the Charity Commissioner, Nagpur.

21. **PROVISION OF ALTERATION IN NAME AND ADDITION TO THE AIMS AND OBJECTS OF TRUST :-**

If the alteration in the name and addition to aims of the trust or annexation between two different trusts have become necessary, same shall be done by passing resolution by 2/3 majority of the Members present in meetings of Board of Trustees and subject to the sanction of Charity Commissioner, Nagpur.

22. **THE AREA OF OPERATION :-**

The area of operation of the Trust shall be whole India.

23. **FINANCIAL YEAR :-**

The accounting year shall be from 1<sup>st</sup> day of April to 31<sup>st</sup> at day of March each year.
